

TRASH TO FASH: AN UPCYCLING COMPETITION

TERMS & CONDITIONS OF ENTRY

Trash to Fash, an upcycling competition (“Competition”), is organised by Temasek Capital Management Pte Ltd (“Temasek”).

Participation in the Competition is subject to the Terms and Conditions (“T&Cs”) as listed in this document. By entering the Competition, participants agree to be bound by and to comply with the T&Cs. Non-compliance with or breach of any of these T&Cs may disqualify a participant at any stage of the Competition, and any prizes won may be forfeited, withheld, withdrawn or reclaimed.

1. By participating in the Competition, each participant agrees that:
 - a. they are at least seventeen (17) years of age at the time of application;
 - b. any and all Personal Data submitted may be collected, used and/or disclosed to and processed by Temasek and its partners (“Organising Parties”) for various purposes, including to communicate with the participant for purposes related to the Competition, to provide goods and services to the participant upon request, and such other purposes that the Organising Parties may deem reasonably appropriate, or in relation to which the participant has otherwise provided the Organising Parties with consent. Each participant further warrants that, to the extent required under applicable data protection laws, it has obtained any consents from, and given any notices to, data subjects for the disclosure of the Personal Data to the Organising Parties and any processing of the Personal Data by the Organising Parties in connection with the Competition. For the purpose of this clause, “Personal Data” means data, whether true or not, about an individual who can be identified (i) from that data; or (ii) from that data with other information which the Organising Parties has or is likely to have access to, and includes “Sensitive Personal Data”, which is information about a person's racial or ethnic origin, political opinions, religious or philosophical beliefs, trade union membership, genetic data, biometric data, physical or mental health or condition, sex life or sexual orientation, offences or criminal proceedings, and which can only be processed under strict conditions (usually requiring the express consent of the person concerned);
 - c. the Organising Parties may collect, use, disclose and share amongst themselves and their respective service providers, the participant’s Personal Data including the photographs, audio-visual material, or other recordings of these participants (“Material”) for publicity and/or use in advertisements across all media, including, without limitation, in the Organising Parties’ publications, presentations, promotional materials on their websites, in its original or edited format, and whether to promote the Competition or otherwise without further notification, remuneration, or compensation;

- d. the Organising Parties will be granted non-exclusive rights to use, reproduce, print, represent, broadcast, display, communicate, transmit, and to modify any and all submissions by participants to the Organising Parties in whole or in part (“Submissions”) for free and on a worldwide basis; and
 - e. they acknowledge and agree to Temasek’s Privacy Statement which may be found at <https://www.temasek.com.sg/en/site-services/cookies.html>.
2. Each participant affirms the accuracy of all information provided at the time of Competition application. Any misrepresentation of any fact or particulars (deemed material by the Organising Parties) may result in disqualification from the Competition and/or the forfeiture, withholding, withdrawal or reclaiming of any prizes won.
3. Each participant affirms that they own their Submissions and all elements, including but not limited to fonts and stock images, contained within it in whole or in part (“Submission Elements”), and that they have the rights, or have obtained the rights, to distribute or modify these Submissions and Submission Elements without infringing on the copyright of other external parties.
4. Each participant undertakes not to submit any items which:
 - a. infringe on another party’s IP rights;
 - b. may be defamatory, libelous or insulting of or to any individual or legal entity;
 - c. encourage to commit fines, offences, or crimes of any kind whatsoever;
 - d. are violent, pornographic, or paedophilic in nature, or likely to violate a minor’s rights;
 - e. are racist, xenophobic, or incites discrimination
 - f. breach public order or decency; and/ or
 - g. breach or are contrary to applicable laws and regulations.
5. Each participant, whether participating as an individual or as a group, may submit only one (1) entry for the Competition.
6. Participants shall not, without the prior written approval of the Organising Parties, speak to the press or any other media nor give any interviews or comments relating to the Competition.
7. In the event that the Participants wish to use their Submissions on a platform that is not a part of the Competition, the Participants are to inform the Ecosperity Programme Office by sending an email to ecosperity@temasek.com.sg before the usage of the Submissions. This email shall contain:
 - a. the name of the event at which the Submissions will be used;
 - b. the purpose of the event at which the Submissions will be used;
 - c. the duration of the event at which the Submissions will be used; and
 - d. the capacity in which the Submissions will be used.

8. All decisions made by the Organising Parties throughout the duration of the Competition, including but not limited to the selection of the twenty-five (25) participating individuals/teams, the selection of the top eight (8) finalists, the selection of the top three (3) winners, and any disqualifications, if any, are made at the sole and absolute discretion of the Organising Parties and shall be final and irrevocable. Any and all disputes arising from any decision made by the Organising Parties will not be entertained.
9. The Organising Parties reserve the right, at any time, in its sole and absolute discretion, to substitute, withdraw, add to or alter any of the prizes offered without notice to the participants.
10. Prizes are not transferable or exchangeable and non-cash prizes cannot be exchanged for cash. The Organising Parties accept no responsibility for any tax or other liability that may arise from the prize winnings. Prizes are subject to availability and the Organising Parties have the right to substitute any prize for a comparable prize of equal or greater value to be awarded in lieu, subject to any applicable law.
11. In the case of cash prizes, there will be one intended party per cheque as cash prize only. Participants in teams are to select one representative as payee. Each payee must provide their full name as per their bank records, as well as other personal particulars requested by Temasek for verification and audit purposes. In the event that the cash prize is won by a group, the responsibility of the division of the cash prize between or among the group members lies solely upon the group members. The Organising Parties are not liable for any disputes arising out of the division of the cash prize.
12. All prizes which are not won or remain unclaimed after 30 days of the announcement of the winners will be forfeited.
13. The Organising Parties will endeavour to conduct the Competition on and at the advertised date, time, and venue, and by the mode as advertised, but reserve the right, in their sole and absolute discretion, to conduct the Competition on and at other date(s), time(s), or venue(s), and by other mode(s) in such circumstances as the Organising Parties may deem appropriate.
14. The Organising Parties, and their partners, vendors, and/or other related parties for the Competition shall not be liable for any loss (including, without limitation, indirect or consequential loss), damage, personal injury or death in connection with the Competition, or any prize, except any liability that cannot be excluded by law (in which case that liability is limited to the minimum allowable by law). If applicable, all warranty claims in regards to a prize should be directed to the applicable partner, vendor, and/or other related parties, except to the extent that they may not be excluded by law, no representations, warranties, terms or conditions that are not expressly stated in these terms and conditions apply to this Competition nor in respect of the prizes and all implied warranties are excluded, including but not limited to, the implied warranties of satisfactory quality, merchantability or fitness for a particular purpose of any of the prizes.
15. Any rights of Temasek under these T&Cs and/or in connection with the Competition may be exercised by Temasek Holdings (Private) Limited and its related corporations (as defined in the Singapore Companies Act (Chapter 50)).
